Overview: We will examine theoretical, clinical, and research perspectives on the connections among psychosis, trauma, and dissociation. Our first readings will focus on historical conceptions, followed by research and clinical perspectives comparing psychotic and dissociative reactions. Finally we will consider both standard and innovative approaches to assessing and treating these hybrid and boundary conditions.
