Course description:

In this course, we will examine many aspects of psychoactive drugs, such a neuropharmacology, toxicity, addiction, abuse, prevention, and treatment. We will explore these concepts and their implications in medical, behavioral, social, and legal contexts. Lectures will be complimented with discussions, texts, articles, and movies designed to reinforce the main concepts and enhance the learning experience.

Participation (10% of final grade)

Participation will be based on *attendance and discussion*. On certain, unspecified days, you will be asked to reply to questions about the lecture by writing responses on index cards, which will be collected at the end of class. Your responses will be evaluated, and they should reflect that you have been actively engaged in the course material. The index cards will also serve as proof that you attended class that day. **In addition, I** *highly* **encourage you to ask questions, raise issues, and connect idea during class!**

Quizzes (20% of final grade – 3.33% each)

We will have 8 short quizzes that will take place during the first 15 minutes of class. Quizzes will consist of 5 multiple-choice questions. Quizzes will pertain to material presented in the lectures and the assigned readings for each week. Each quiz will only cover the material from that particular week (e.g. Quiz 1 will only relate to information covered during Week 1). Your lowest 2 quiz grades will be dropped. Therefore, there will be NO MAKE-UP QUIZZES offered. Please let the instructor know if you need to miss more than two quizzes.

Small Group Responses (25% of final grade - 5% each)

You will form small groups of \sim 5 people, and you will find a time outside of class to discuss controversial topics related to psychoactive drugs. This discussion time will provide you with the opportunity to engage in a lively discussion with your classmates, and it should help you generate ideas for the assignment.

The Small Group Response (SGR) assignment <u>must be completed independently from your other group members</u>. It should present your opinion about the topic, while demonstrating that you understand the topic and the related issues. It should reflect what you discussed in your small group, but it should also present your own ideas and opinions.

The topics will be posted on Blackboard on Wednesdays after class, and your **SGR will be due the following Wednesday by 2pm**. Please submit your SGRs via Blackboard.

*Please note that there is not a final paper for this course.

Exams - Midterm (20% of final grade); **Final** (25% of final grade)

These exams will consist of multiple choice questions, true/false questions, fill-in-the-blank questions, matching, figure labeling, and short answer questions. Both exams will be comprehensive, although the final exam will focus more on material covered during the second half of the class.

In addition, a plus or minus will be appended to letter grades for scores in the upper and lower third of each grade range, respectively.

Option 1: Participate in research plus RER – up to 2 credits/hours

You may participate in real research experiments through the Psychology and Linguistics Departments' Human Subject Pool. Researchers conduct many experiments on varied topics (e.g., attention, social interaction). Through participating, you will gain an understanding of how research is conducted. There will be an option for you to request a username and password. Once logged in, you will find a list of studies and their locations that are available to you. After participating in a study, you will be electronically credited for the time allotted for that study.

Option 2: Read an article plus RER – up to 2 articles

You may also fulfill all or part of the research participation requirement by reading research articles. Each article you read will count as 1 credit and take about one hour to read thoroughly. By reading about empirical research, you will gain knowledge of the methodology used in psychology studies.

Research Experiment Reports (RERs): In order to ensure that you understand the experimental hypotheses, methods, etc. you will need to complete an RER electronically on Blackboard after participating in either option, above.

*In order to receive Extra Credit for research participation, all RERs MUST be submitted on Blackboard on **Wednesday**, **June 6**, **2012 by 2pm**

1 credit/hour participation + RER = 1 article + RER = 1% EC
