Theories and Models of Consultation and Supervision Psy 610-Winter 2019

Course Overview:

Students will learn about major theories, models, modes of delivery, and ethical considerations of clinical consultation and supervision. Through didactics, reflective writings, review of original empirical research, and through providing supervision to a peer, students will learn about and practice consultant and supervisor-in-training roles. The goal of this course is for students to work towards competence in order to eventually consult or supervise effectively as licensed psychologists. In addition, students will learn how to research original studies geared toward the advancement of supervision and consultation.

*The course is optimal for students who have completed at least one year of clinical practicum.

Evaluation: This is a pass/no pass course. Unsatisfactory performance on any of the evaluation components could result in a 'no pass' designation. Students will be evaluated on the following class components/assignments:

- 1) 15%. **Empirical Report.** In groups of 2-3 (need to be 4 groups total), students will select a recent (2015-present) article from the *Clinical Supervisor* or *Training and Education in Professional Psychology* in which empirical research was reported. The article should correspond with the topic of that week's class. Students will present a 15-20 minute powerpoint to the class covering:
 - Introduction of the topic and why you choose the specific article (~5 min).
 - Methods and results (~5-10 minutes),
 - Discussion of implications,
 - If applicable, one realistic recommendation for how our program could implement a change that would align with the article results,
 - Then, the class will discuss the article for 5-10 more minutes.
- 2) 45%. **Response papers.** (15% each) Starting in the second class, I will provide various paper prompts based on the readings. The responses are to be approximately 500 words in length. The prompt will be due by Friday at 10pm the evening before the following class. Email me the paper.
- 3) 40%. **Supervision practice.** Students will gain experience supervising as part of their advanced practicum. Students in the advanced DBT prac will watch and provide supervision to another DBT group leader/co-leader. Students in the Couple prac will provide supervision on another student's individual case. The groups will be established in class two. You will be responsible for filling out a pre-supervision plan, conducting the supervision (either with me and/or Crystal present), and completing a post-supervision form. *Remember that the licensed supervisor retains final supervisory input regarding case.
