## Number of Incidents Indicated and Reported Provided to the University of Oregon AAEO October 13, 2014

Based on preliminary results from the UO Sexual Violence and Institutional Behavior Campus Survey

We recently conducted a campus survey that collected information regarding UO student exposure (while at college) to sexual violence and related matters. Prior to this report we have presented some of our preliminary findings including the number of students in our sample who indicated they had been subjected to sexual experiences without their consent (see <a href="http://dynamic.uoregon.edu/jif/campus/">http://dynamic.uoregon.edu/jif/campus/</a>).

We have compiled this specific information for the UO AAEO. This document pertains to the number of nonconsensual sexual *incidents* that our participants indicated they had experienced (based on the 7-item Sexual Experiences Survey [SES; Koss et al., 2007]). Participants who indicated they had experienced a certain kind of event were then asked to indicate the number of times the event occurred (during college). It seems likely to us that this information should be included in UO aggregate data regarding reports that come to university sources<sup>1</sup>. All these values pertain only to the students who completed our survey, which is about 5% of the current undergraduate population. On the following pages we present in tabular form the number of students reporting a particular kind of experience and the number of total separate incidents.

In addition we are providing information that pertains to the number of students who indicated they told a university source about a nonconsensual experience. In that case, we have data on a per-student rather than per-incident basis. In our table we have one column labelled *number of students who reported*; this is essentially the minimum number of reports the university should have received from these particular students. In another column labelled *potential reports to university* we are attempting to account for students who indicated they experienced multiple incidents of a given type of event and who also indicated they reported to a university source. This number is therefore a projection assuming they reported each distinct incident.

<sup>&</sup>lt;sup>1</sup> Our participants were current students who had been at the UO one or more years. Although we asked participants how many academic years at the UO, we do not have specific calendar year information from participants regarding incidents. For some purposes, such as Clery data, year of report is used for official statistics, rather than year of incident (<a href="https://www2.ed.gov/admins/lead/safety/handbook.pdf">https://www2.ed.gov/admins/lead/safety/handbook.pdf</a>).
