When we use information from your check to make an electronic fund transfer, funds may be withdrawn from your account as soon as the same day we receive your payment, and you will not receive your check back from your financial institution. Options:	Regular Plan	Pay four monthly installments on a 6-month policy or nine monthly installments on a 12-month policy. Exception: Not available in Puerto Rico.
	Extended Plan	Pay six monthly installments on a 6-month policy or twelve monthly installments on a 12-month policy. In Puerto Rico, pay four monthly installments on a 6-month policy or six monthly installments on a 12-month policy.
	Pay In Full Plan	Failure to pay in accordance with these payment options may result in nonpayment cancellation action. This may cause your account to be placed on Pay In Full, and full payment is required by due date. May vary by location.
Fees and Charges:	Late Fee	Assessed at the end of the billing period and is added to the current installment when no payment is received or the total payment received is less than the Extended Plan amount. Late fees can be up to \$15 and vary by location.
	Returned Payment	A fee, based on amount applicable by law, is assessed to your account for each payment a financial institution returns to USAA.

General Information:

If you adjust your coverage and the premium changes, the amount is prorated over the remaining installments. Revised statements are not sent.

***Legal terms for automatic payments using a bank account:**

- USAA is authorized to withdraw money from the account you have specified according to the payment option you choose. Refunds will be deposited to the same account.
- You must have enough money in your account, and the funds must be received before your bill is paid.
- This agreement will remain in full force and effect unless canceled by you (by writing to us or calling us), USAA, or your financial institution in such time and manner to allow a reasonable opportunity to act on it.
- Any changes made to the withdrawal amount must be made five business days prior to the withdrawal date.
- The origination of ACH (Automatic Clearing House) transactions to your account must comply with the provisions of U.S. laws and regulations.
- You are a signature authority on the account you use for the automatic payment plan.
- USAA may make a withdrawal prior to the policy effective date, but will always notify you on your billing statement.
- If an error is made, USAA can correct it by making withdrawals or deposits, but only up to the amount indicated on your billing statement.
- If the amount due on your insurance account is less than the payment amount required under your selected payment option, USAA will debit your bank account just for the amount due.
- A return payment fee will be added to your bill for each payment a financial institution returns.
- USAA will not debit your bank account if the amount due is zero.
